

Editorial Guidelines for *Ethics & Medics*

Ethics & Medics is a monthly commentary providing analysis, argument, and opinion concerning advances in the health and life sciences. We have been in print for over 40 years and have a readership of approximately 15,000. *Ethics & Medics* publishes articles that are faithful to the Catholic moral tradition and its official teaching, but is not a publication of the Catholic Church. The various authors are responsible for the opinions and arguments advanced in the articles they write. Our readers are clergy, medical professionals, administrative health care personnel, teachers, lawyers, students, and interested Catholics and non-Catholics alike.

A good article addresses some issue in health care that is important for those who honor the great moral tradition of the West. An article may inform the reader of a new development in medicine, law, moral philosophy, or moral theology; it may present and defend a position that remains unsettled within the Church; or it may discuss the pastoral implications of a subject generally related to medicine or morality. In any event, a good article helps the reader think about and understand some particular issue in medical ethics and/or bioethics.

Policies

The editor and staff of The National Catholic Bioethics Center review and determine the content of *Ethics & Medics*, in conjunction with a number of outside consultants, some of whom are specialists in the various fields of interest to the readers of our bulletin. All editorial changes are reviewed with the author; we do not print without final author approval. Whenever agreement between editor and author cannot be reached, the article either will be returned to the author or temporarily set aside.

The editorial staff of the Center is available to assist authors with their work. Please contact the editor at efurton@nbccenter.org if you have particular needs. All submitted articles are corrected grammatically and stylistically here at the Center.

Articles should be submitted as electronic mail attachments in some Windows compatible format. We can receive work in Microsoft Word, OpenOffice, or plain ASCII text. For those with a proposed topic who need a deadline, these are generally set four weeks from the date of assignment. If you believe that you will need an extension on your deadline, please let us know.

Authors whose articles are published, and who are not otherwise affiliated with the Center, may receive a modest stipend for their contribution. The National Catholic Bioethics Center holds copyright but freely grants permission to reprint so long as mention is made of first publication.

Style

The Center uses the *Chicago Manual of Style*, 16th edition. Documentation of sources, when necessary, appears at the end of the article, which should be approximately 1,600 words (including notes) and divided into three or more short sections with headings. We sometimes publish double-length articles.

Authors should indicate how they would like to be identified at the end of the article. The usual format is name, position, institution, city, state. You may also include your e-mail address.
